Do You Recycle at Your Workplace?

It's Easy To Do

Step 1: Get the manager or owner's approval.

Step 2: Call Recology at 831-636-7500 and ask for Julie Alter for assistance. Julie will find out what your needs are whether you need a white dumpster for paper and cardboard or a blue cart for paper and food & beverage containers. If you have garbage service, you can add on recycle service at no charge.

Step 3: Watch for the delivery of the recycle container.

Step 4: Educate the employees and maintenance staff

Step 5: Recycle!

On July 1, 2012, the State adopted AB 341, a mandatory recycling law that affects businesses and multifamily complexes. Businesses that generate at least 4 cubic yards of garbage per week need to have a recycling program, and multifamily complexes with 5 or more units need to have a recycling program.

To help California meet the increased recycling goal, Recology San Benito offers free waste assessments. Julie Alter, Waste Zero Specialist, will look inside your garbage dumpster and determine what material can be diverted from disposal and recycled.

Does Your Business Generate Hazardous Waste?

You May Qualify For The Conditionally Exempt Small Quantity Generator Program

Hazardous waste must be properly disposed of to prevent pollution to our land, water, and air. To assist businesses, the San Benito County Integrated Waste Management Regional Agency hosts hazardous waste collection events the third Saturday of every month by APPOINTMENT ONLY. This Hazardous Waste Program is an affordable and convenient collection event to legally dispose of hazardous waste for businesses qualifying as Conditionally Exempt Small Quantity Generators (CESQG). Fees will depend on the type and quantity of waste.

California State and Federal law requires all businesses and industries that generate, store or accumulate hazardous waste to comply with regulations for proper treatment, storage and disposal of these wastes. Generators of small quantities of hazardous waste may be conditionally exempt from many of these regulations if they ensure delivery of the waste to permitted hazardous waste management facilities or to temporary collection facilities.



You qualify as a CESQG if you generate per month:

- · Less than 220 pounds of most hazardous waste
- Less than 2.2 pounds of acutely hazardous waste
- Less than 110 pounds of perchloroethylene Call the San Benito County Integrated Waste Management Regional Agency at (831) 636-4110 to find out more about this collection program.

Examples of acceptable hazardous waste materials include:

- Fluorescent bulbs/tubes
- Thermometers
- Batteries
- · Propane/helium tanks, aerosol cans
- · Motor oil & filters
- Lubricants
- Antifreeze
- Pesticides
- Herbicides Fungicides Fertilizers
- · Latex & oil-based paints Stains & varnishes
- Roofing tar
- Adhesives
- Acids

Things You Can Recycle in Your Blue Cart at Work

You might be surprised to know the variety of recyclables that you can put into your blue cart at work. If you don't have one yet, call us and request it!

- Magazines & catalogs
