









FOOD: Too Good to Waste Challenge



Do you have rotting fruits, moldy vegetables, or to go boxes of unknown leftover food in your refrigerator? You are not alone when it comes to food waste. On average, Americans waste 25% of food they purchase.

Are you ready to make a difference and reduce food

waste? A shift in the way we shop, prepare and store food can greatly reduce the amount of wasted food. Changing our behavior on food waste can also save us money.

According to the West Coast Climate Forum, if families were more conscientious about food waste, an average family could save over \$30/week (\$1600 a year) if they follow the Food: Too Good To Waste Toolkit.

So how do we create food waste?

Food is wasted if we:

- Buy more than we need
- Discard leftovers
- Cook too much
- Improper storage



Why is Food Waste Reduction important?

- Food Waste is the largest single source of waste sent to landfill. Food decomposes in the landfill creating a greenhouse gas called methane, which is contributing to climate change.
- It saves natural resources. Water, gasoline, energy and land are used to make the food we throw out. By wasting food, we essentially waste all the natural resources used to make that food.
- If food waste reduction is unattainable, place food waste in the compost. Compost will be used to return nutrients back to soil and grow new food.

Green Cleaning Tips



Many modern home cleaning products contain toxic and polluting chemicals that are harmful to your family and the environment. There are natural easy to use alternatives found in your cabinets that can be used alone or in combination to easily clean your home.

- WHITE VINEGAR removes mildew and cuts grease
- BAKING SODA cleans and deodorize
- BORAX cleans, deodorizes, and disinfects
- LEMON cleans most household mildew

Homemade All-Purpose-Cleaner Recipe

Mix 1/2 cup vinegar and 1/4 cup baking soda into 1/2 gallon water. Store and keep (2 teaspoon of borax can be used in place of baking soda).

Don't leave furniture, mattresses, tires, appliances, garbage, hazardous and universal waste in public right of way or large unattended areas, such as sidewalks, streets and parking lots. Please be sure to pull your carts back from the curb once they are serviced. We are not responsible for any articles left on or near collection containers.

Twice Annual On-Call Collection - Valid July 1, 2016 - June 30, 2017

Residents in single-family homes, duplexes, and triplexes are entitled to two free curbside pick-ups per year of extra garbage, bulky items (i.e. furniture), and extra yard waste.

Hazardous items, and Construction and Demolition (C & D) debris cannot be collected at the curb. Please see articles HHW and debris box information for removal options.

Each collection is limited to three cubic yards (3 ft. x 3 ft. x 9 ft.). Excess of three cubic yards will not be picked up; however, if you wish to use both collections at the same time (six cubic yards), you may request it when you place your order.

Extra yard waste must be placed in heavy-duty paper bags, cardboard boxes, or tied in small bundles and stacked neatly, and not to exceed 20lbs. This material must be cut down to 4ft or less in length.

On-Call collections do not carry over from year to year. This service is offered Monday - Friday, on your regular service day. Weight limits may apply and acceptability of items are at the discretion of the driver.

Textile Recycling Did you know we can recycle old textiles like clothes, bedding and blankets? Unfortunately, only 15% of all textiles are recycled while the remaining 85% are sent to landfills. - Small household appliances (like microwaves, radios, and VCR's)

Pharmaceutical and Sharps Disposal

Pharmaceutical Disposal: Dispose of old medications in a confidential drop-off container at the San Bruno Police Department: 1177 Huntington Avenue anytime of day or night.

Sharps Disposal: Sharps are defined as medical devices used for self-injection or blood tests which have a sharp tip or end. Contact your Doctor, Pharmacist or Hospital and ask if they offer a take-back program.

Recycling Facts

- Glass has the fastest turnaround time for recycling making its way back to shelves in as little as 30 days.
- Approximately 1 billion trees worth of paper are thrown away each year in the U.S.
- Americans throw away roughly 102.1 billion plastic bags every year.
- Almost half of the food in the U.S. goes to waste—About 3,000 pounds per second.

Service Reminders

MISSED COLLECTIONS:

Please report any missed collections to our office by the following business day. An answering service is available after regular business hours to accept all calls.

EXTRA GARBAGE AND CARDBOARD:

Lids for garbage and recycling carts must be completely closed. Extra garbage must be bagged and arrangement made with our office in advance for pickup.

Extra Bag Tags are available for a fee by calling Recology San Bruno at 650-583-8536, or the City of San Bruno Utility Billing Division at 650-616-7086.

Flatten and tie your extra cardboard into a 3ft. x 3ft. bundle (not to exceed 20 lbs) and place next to your recycle cart.

BATTERIES:

Recycle your household batteries by sealing them in a clear plastic bag and placing ON TOP of your recycling cart.

RECYCLING THEFT:

Unauthorized collection of recyclable materials is a violation of San Bruno Municipal Code Section 10.22.140. Violators will be prosecuted and subject to fines. If you are a witness to this crime, please call the San Bruno Police Department business line at 650-616-7100.

Recology San Bruno is the Exclusive Franchise Debris Box hauler for San Bruno. Call before 10am Mon-Fri for same-day debris box service. Payment due at time of order. Construction and Demolition (C & D) Recycling Ordinance documentation is available upon request - please request at time of order.
