Purchasing Products Made From Recycled Materials

Does your business have a policy to purchase supplies made of recycled material? Buying recycled-content products reduces waste going to landfills, reduces manufacturing waste and pollution, frequently reduces energy consumption, and creates jobs. Most importantly, buying recycled-content products ensures that the materials collected in recycling programs will be used again in the manufacture of new products.

Check with your current office supply company to see which recycled products they carry. If they don't have a great selection, search on the Internet for "recycled office supplies" and see what you can find.

These are just a few examples of recycled-content products:

- Trash bags
- Tissue products
- Binders
- Business cards
- Computer paper
- Printing & writing paper
- Pens and pencils
- Toner cartridges
- Envelopes
- Calendars

When looking for items to purchase, first search for products with "post consumer" recycled content. This means the item is made from material (like office paper) that was collected through a recycling program, baled, sold and recycled into a new product—like a pad of writing paper. If you can't find the "post consumer" information on the product, then look for "recycled content" information. These products are made from materials that would otherwise have been discarded like odds and ends from the manufacturing process.



Does Your Business Generate Hazardous Waste?

The San Benito County Small Quantity Generator Collection Program can help you recycle it responsibly!

What is a Small Quantity Generator Collection Program? California State and Federal law requires all businesses and industries that generate, store, or accumulate hazardous waste to comply with regulations for proper treatment, storage, and disposal of these wastes. Generators of small amounts of hazardous waste may be conditionally exempt from many of these regulations if they ensure delivery of the waste to permitted hazardous waste management facilities. San Benito County can assist your business with this process if you generate per month:

- Less than 220 pounds of hazardous waste
- Less than 2.2 pounds of acutely hazardous waste. This is approximately equal to one quart of liquid with a comparable weight to water.
- Less than 110 pounds of perchloroethylene. This is approximately equal to 13 gallons of liquid with a comparable weight to water.
