

## GET THE FACTS! ¡INFÓRMESE BIEN!



You can still reduce single-use during the COVID-19 pandemic. When ordering take-out, ask to “hold the utensils.” Bag your own groceries at the store with reusable bags, OR, place items loose in your cart and bag them in reusable bags at your car.

*Aún puede reducir el uso de los productos desechables durante la pandemia de COVID-19. Cuando ordene comida para llevar, pida “que no le den los utensilios de plástico”. Empaque usted mismo los comestibles en la tienda usando sus bolsas reutilizables. O, coloque los artículos sueltos en su carrito y luego póngalos en bolsas reutilizables en su automóvil.*



**Personal Protective Equipment (PPE) belongs in the garbage.** Gloves and masks are not recyclable or compostable. It is very important that we keep these items off the streets, out of the recycling, and place them in the garbage.

*El equipo de protección personal (EPP, por sus siglas en inglés) van en la basura. Los guantes y máscaras no son reciclables o compostables. Es muy importante que mantengamos estos artículos fuera de las calles, fuera del reciclaje, y los ponga en la basura.*



**Compost combats climate change.** Placing your food scraps in your green compost cart allows them to live on as rich nutritious compost, that will pull carbon from the atmosphere into the soil where it belongs. Composting food scraps also prevents them from producing potent methane gas in the landfill, and conserves landfill space.

*El compostar combate el cambio climático. Colocar los restos de comida en su bote verde para el compostaje permite que estos desechos sigan viviendo como una rica y nutritiva composta, extrayendo el carbono de la atmósfera y poniéndolo en la tierra, a donde pertenece. El compostaje de los restos de comida también impide que se produzca potente gas metano en el vertedero de basura y ahorra espacio.*



**Wet paper is not recyclable.** Keeping the lids closed on your recycle cart is crucial during the rainy season. When cardboard and paper get wet, they cannot be recycled.

*El papel mojado no es reciclable. Mantener las tapas cerradas en su carrito de reciclaje es muy importante durante la temporada de lluvias. Cuando el cartón y el papel se mojan, no se pueden reciclar.*



## WASTE ZERO SERVICES

California State laws AB341 (Mandatory Commercial Recycling) and AB1826 (Mandatory Commercial Organics Recycling) require accounts with 4 cubic yards or more of solid waste per week to have recycle and compost service. Let our Waste Zero Team help your school, business, or multi-family dwelling recycle and compost more, while saving money on your monthly bill!



## SERVICE REMINDERS RECORDATORIOS DE SERVICIO

Please do not pile leaves from your property on the street. Place them in your compost cart instead. As well, please refrain from parking on the street on sweep day. Your street sweeping schedule can be found at [Recology.com/Healdsburg](http://Recology.com/Healdsburg) under “Schedule” at the top of the page.

*No apile las hojas de su propiedad en la calle. Póngalas en su contenedor para los desechos del jardín. Evite estacionarse en la calle el día de barrido. Encuentre su día y horario de barrido visitando [www.Recology.com/Healdsburg](http://www.Recology.com/Healdsburg).*



Proper cart placement is important. Lids should be closed, and carts should be placed 3 feet apart the night before your service day. Ensure there is 12 feet of clearance above each cart - avoid trees and basketball hoops.

*La colocación adecuada de los botes es importante. Los botes deben colocarse a 3 pies de distancia la noche anterior a su día de servicio. Las tapas deben estar cerradas, no llenar en exceso. Asegúrese de que haya 12 pies de espacio libre sobre cada carrito, evite árboles, canastas de baloncesto, etc.*

### HOLIDAY COLLECTION SCHEDULE

There will not be collection service on Thanksgiving, Christmas, and New Year's Day. Service will be delayed by one day for those holidays. You can check your service schedule at [Recology.com/RSMschedules](http://Recology.com/RSMschedules).

**HOLIDAY TREE RECYCLING** - Trees must be cut in half, unflocked, and metal stakes removed.

Drop-off available at the City Corp Yard from December 26th - January 15th.

Drop-off available at Sonoma County Transfer Stations from December 26th - January 15th.

Curbside collection available from December 28th - January 8th.

#### Gifts

- Give a consumable gift. Local honey, cookies or a home cooked meal will always be appreciated.
- Consider finding a used treasure at Craigslist.org, Facebook Marketplace, or an antique store.
- Make a donation in the recipient's name to a favorite non-profit organization.

#### Giftwrap

- Give gifts in reusable tote bags or baskets.
- Design your own gift wrap by using paper bags or newspaper with a personal touch.
- Metallic wrapping paper or gift bags and ribbons are not recyclable.





# WHAT GOES WHERE?



## COMPOST



- ✓ **Food scraps (produce, meat, bones, dairy, bread)**  
*Restos de comida (productos, carne, huesos, productos lácteos, pan)*



- ✓ **Plant trimmings**  
*Recortes de plantas*



- ✓ **Food soiled or wet paper (napkins, paper towels, pizza boxes)**  
*Papel sucio (Servilletas, toallas de papel, cajas de pizza)*



- ✓ **Wooden utensils, chopsticks, & stir sticks**  
*Palillos chinos y palitos de madera*

✗ Plastics (even those labeled "compostable") and paper coated with plastic (i.e. paper coffee cups) are not accepted in compost.

✗ Dirt weighs down your cart and damages our equipment. Small amounts are okay. Shake those roots!



## RECYCLE



- ✓ **Aluminum & steel cans**  
*Latas de aluminio y acero*
- ✓ **Aluminum foil & trays**  
*Papel y charolas de aluminio*



- ✓ **Plastic containers (bottles, tubs, jugs, & cups) - leave lids on**  
*Contenedores de plástico*



- ✓ **Glass bottles & jars - leave lids on**  
*Botellas y frascos de vidrio -Deje las tapas puestas*



- ✓ **Paper, cardboard, & cartons**  
*Papel, carton, y cartones*

✗ Recyclables must be empty & dry. No food or liquids.

✗ Plastic bags are not recyclable in our mixed recycling program and they damage our sorting equipment.



## HOUSEHOLD HAZARDOUS WASTE (HHW)



**DO NOT dispose of household hazardous waste in garbage, recycle, or compost bins.** It is extremely dangerous to sanitation workers and must be disposed of properly. **Zero Waste Sonoma** has several options for proper disposal of household hazardous waste. **NO deseches los residuos peligrosos del hogar en los contenedores de reciclaje o de desechos del jardín (composta).** Estos son extremadamente peligrosos para los trabajadores del sitio de recolección y deben eliminarse adecuadamente.
