California Law Requirements for  
Businesses and Multi-Family Dwellings



## MANDATORY COMMERCIAL ORGANICS RECYCLING

Assembly Bill 1826 (AB 1826) is a law enacted by the State of California that requires businesses and Multi-Family Dwellings to begin compost service.

The first phase of AB 1826 focused on organic waste in the garbage. **Generators of 4, 8, or more cubic yards per week of organic waste currently needs to have compost services.**

### PHASE TWO IMPLEMENTATION

The second phase of AB 1826 focuses on garbage service. Generators of the following garbage volumes will need to have compost service by the corresponding dates.

**JANUARY 1, 2019**

**4** Cubic Yards (or more) per week of Garbage, Recycling & Compost combined

**JANUARY 1, 2020**

**2** Cubic Yards (or more) per week of Garbage, Recycling & Compost combined

## WHAT GOES IN THE COMPOST BIN?

We accept all food scraps, food soiled paper products, coffee grounds & filters, meat, bones, fish, dairy, waxed cardboard, clean wood, and yard waste.



## MULTI-FAMILY DWELLINGS

Multi-Family Dwellings are not required by AB 1826 to compost food waste, but they are required to ensure that **yard waste and landscape materials** generated on-site are composted. However, if you would like to start a compost program at your property for food waste, we can help.
