#### MANDATORY COMMERICAL ORGANICS COLLECTION

Are you covered by Assembly Bill 1826 and/or Senate Bill 1383? These are California's mandatory commercial organics recycling laws.

AB 1826 requires all commercial generators of 2 cubic yards or more of combined garbage, recycling and organic materials per week, to recycle their organic materials.

The City Council adopted Ordinance No. 1079 Solid Waste, Recyclables, and Organic Waste Disposal on Nov. 16, 2021. The ordinance requires all generators of organic material to properly sort and recycle their organics.

Organic materials include food scraps, food/beverage soiled paper products (e.g., pizza boxes, paper towels, paper cups and plates) and yard and tree trimmings.

Organics and compostable materials placed in landfills break down without oxygen. As a byproduct of the decomposition, methane is emitted into the atmosphere. Methane is 84 times more potent than carbon dioxide and is one of most potent greenhouse gases.

Any exemptions granted to a business or property under AB 1826 are no longer valid but can be reevaluated under the SB 1383 regulations.

## REBATE FUNDS TO INSTALL ELECTRIC VEHICLE CHARGING STATIONS
